#### HOW TO PARTICIPATE IN THE DOWNTOWN STEERING COMMITTEE MEETING

You can participate in the meeting in a number of ways.

**Public Comment on Agenda Items** - If you wish to address the Downtown Steering Committee, you must complete a speaker card for Agenda Item 2, *Opportunity for the Public to Address the Downtown Steering Committee on Workshop Items.* The speaker card box is located in the Council Chambers lobby. Place your speaker card in this box and staff will collect the cards immediately before the agenda item. The Chairperson will call speakers to the public lectern. No cards will be accepted once the public comment period has commenced. Speakers are limited to a maximum of three minutes per person. The Chairperson may reduce the amount of time based on the number of people wishing to speak.

**Written Materials** may be submitted by the public. If you wish your materials to be sent to the Downtown Steering Committee before the meeting, they must be submitted to the Community Development Department no later than 5:00 p.m., seven days prior to the scheduled meeting. Submitted materials will be copied and provided to the Downtown Steering Committee with the agenda packet. Materials submitted after this deadline will be copied and given to the Downtown Steering Committee, provided they are received in the Community Development Department no later than 12:00 p.m. on the day of the Steering Committee meeting.

The **Downtown Steering Committee Agenda** and any Staff Reports are prepared by City staff and are available for public review at least 72 hours prior to the meeting at City Hall located at 1052 South Livermore Avenue and on the city's website at <a href="http://www.cityoflivermore.net">http://www.cityoflivermore.net</a>. Copies will be available for public review at the meeting.

Under Government Code §54957.5, any **supplemental material** distributed to the members of the Downtown Steering Committee after the posting of this agenda will be available for public review at City Hall located at 1052 South Livermore Avenue, Livermore. If supplemental materials are made available to the Committee members at the meeting, a copy will be available for public review at the meeting location.
